Description of requirements:

UNFPA is inviting Expressions of Interest (EOIs) from eligible suppliers in respect to the provision of Repair/Facelifting/Renovation of existing maternity units to be upgraded as BEMONC Centers over the next 3 years (2024 - 2026).

Project Overview:

The aim of this project is to ensure the maternity units at the Community Health Center (CHC) facility meets the required standards and continues to provide the essential Basic Emergency Obstetric and Newborn Care (BEmONC) services to the communities at municipality levels.

Scope of Work:

The selected contractor(s) will be responsible for:

1. Assessment of the current condition of the Maternity Units at the CHC.

2. Detailed repair and renovation plan, addressing structural, electrical, plumbing, and other necessary improvements.

- 3. Compliance with local building codes and regulations.
- 4. Replacement or refurbishment of facilities as required.
- 5. Ensuring the facility meets all necessary safety and accessibility standards.

Eligibility Criteria:

Interested parties must demonstrate:

- 1. Proven experience in the repair and renovation of healthcare facilities.
- 2. A track record of completing similar projects on time and within budget.
- 3. Possession of required licenses and certifications.
- 4. Ability to adhere to quality and safety standards.
- 5. Financial stability and capacity to undertake the project.

Submission Requirements:

Interested parties should submit the following documents:

- 1. Letter of Interest (LOI) expressing the intent to participate.
- 2. Company profile, including relevant experience and project portfolio.
- 3. Financial statements for the past three years.
